Abington Health Foundation

The Faulkner Family Foundation

In 2020, hospitals and health systems needed to raise enough money to offset the mounting costs of treating Coronavirus pandemic patients. Among hospitals large and small, and in every part of the state, preparing for and responding to COVID-19 has brought tremendous financial strain. Abington Health Foundation received a grant from the Faulkner Family Foundation. Gail Faulkner has been an auxiliary of Abington Memorial Hospital since 1981, and a member of the Women's Board since 1991. She has participated as Chair of the June Fete, the Gala, the Asplundh Cancer Center Capital Campaign Committee, and numerous other fund-raising efforts and committees. She currently serves on the Thomas Jefferson University Hospital's Institutional Advancement Board. Ms. Faulkner says that her legacy of philanthropy and volunteerism has brought her great joy, friendship, and satisfaction. Healthcare philanthropy has never been more important and the Faulkner Family Foundation gave generously to support their community's needs. The Faulkner Family Foundation also provided grants to the Greater Philadelphia YMCA, Pennypack Ecological Restoration Trust, and Abington Friends School, among others.



Penn State University Philanthropic Fund

The Paul K. and Anna E. Shockey Family Foundation

In 2020, the Paul K. and Anna E. Shockey Family Foundation donated to create the "Shockey Family Research and Discovery Endowment" at Penn State Hershey College of Medicine, through the Penn State University Philanthropic Fund. Penn State College of Medicine strives to be a national leader in pursuing basic, clinical, translational and health services research; developing programs to advance medical and scientific knowledge; and promoting the development of physician-scientists. Clinical research and biomedical sciences research are both crucial to the continued advancement of medical knowledge.

Allegheny Health Network

The Biondi Family Foundation

In 2020, the Allegheny Health Network received a grant from the Biondi Family Foundation. Thanks to the generous support of area donors, Allegheny Health Network was able to increase access to Coronavirus testing with mobile testing units. Underserved communities in the Western Pennsylvania and Erie areas were able to get tested close to home because of donors who met the needs of the hospital in order to serve the community. Donations also helped the hospital get needed masks and suits to protect healthcare workers.





Ronald McDonald House

The Greater Pittsburgh Automobile Dealers Association Foundation

While the world's healthcare systems were strained by the pandemic, childhood illness and injury continued. Ronald McDonald House of Pittsburgh and Morgantown never closed their doors, continuing to serve those in need. Families who were already facing adverse situations being far from home with a sick child could count on the Ronald McDonald House to help them during an exceptionally challenging time. In 2020, the Ronald McDonald House of Pittsburgh and Morgantown received a grant from the Greater Pittsburgh Automobile Dealers Association Foundation. The donation marked the 5th year of donations totalling \$100,000 by the GPADA and its Foundation.

Children's Hospital of Philadelphia

The Joseph and Mary Faulkner Family Foundation

Angela, Calvin and their daughter Briana have experienced how Children's Hospital of Philadelphia (CHOP) has managed its response to the COVID-19 pandemic from several different perspectives: a specialty care visit, a nine-week hospital stay for a life-saving surgery and a short inpatient stay as an immunocompromised patient. When she was about 10 weeks old, Briana was diagnosed with biliary atresia, a condition in which the bile ducts outside and inside the liver become scarred and block the flow of bile into the intestines. It became clear Briana would need a new liver; she was put on the transplant list in February. She came under the care of CHOP's Liver Transplant Program, one of the most active liver transplant programs in the country. Today, Briana has been gaining weight and shows no sign of rejecting her new liver. Her scar has healed well. She is standing with support, crawling, singing and smiling. Her story is just one example of the life-saving care provided by CHOP. In 2020, the Joseph and Mary Faulkner Family Foundation generously donated to the Children's Hospital of Philadelphia, making stories like Briana's possible. They also gave to Bryn Mawr Hospital Foundation and other organizations in the greater Philadelphia area.



Greater Pittsburgh Community Food Bank

The Rob and Christina Cochran Family Foundation

Due to the pandemic, the greater Pittsburgh region experienced a 42 percent rise in food insecurity. In addition to sudden, increased unemployment, many of the grocery store shelves were empty as supply chains were disrupted. With schools closed, children were no longer guaranteed a lunch meal. Through the Rob and Christina Cochran Family Foundation and #1 Cochran Subaru a significant contribution of \$200,000 was made to the food bank which helped provide more than one million meals to neighbors facing hunger. Employees from #1 Cochran also gathered in June of 2020 to hand out food at a drive up distribution at which more than 500 families were served.

City Team Chester

The David P. Kelleher and Marlo Pagano-Kelleher Family Foundation

Each year for the past 13 years, Dave Kelleher has been coordinating the Adopt A Child Program administered through City Team Ministries in Chester. While in previous years, people could bring a gift to his dealership, due to COVID Mr. Kelleher asked people to donate to the charity directly and online. Bicycles, dolls, and other gifts may not have piled as high in his showroom in 2020, but the giving continued. The David P. Kelleher and Marlo Pagano-Kelleher Family Foundation continued its tradition of giving to help City Team

Chester. One of the major differences between Adopt A Child and other charities is that donors know for whom they are buying. Mr. Kelleher matched every donation that came in so that twice as many kids would get Christmas presents. "Our goal is to 'adopt' 150 children, but I'll double that so that 300 can enjoy the holiday," he said. The David P. Kelleher and Marlo Pagano-Kelleher Family Foundation also supported Auto Dealers CARing for Kids Foundation and several schools in their community in 2020.



Manna on Main Street

The J.L. Freed Foundation

Manna on Main Street is committed to ending hunger in the North Penn region by providing food, fulfilling social service and education needs, and conducting community outreach. Through a food pantry and soup kitchen, emergency financial aid, counseling and referrals, and education opportunities, they serve those in need. Since mid-March when COVID-19 changed our lives, volunteers have served 3,705 hours. These volunteers have bagged to-go meals, sorted through donations, distributed grocery bags, and prepared meals to be delivered through Meals on Wheels. Manna on Main Street runs with the help of volunteers and through donor support. In 2020, Manna on Main Street received a generous donation from the J.L. Freed Foundation





Farm of Hope

The Lewis Family Foundation

Farm of Hope's goal is to provide adults who have developmental and intellectual disabilities a day program to maximize their abilities. "Growers", as they are called, take part in various community activities including volunteering in the local community, visiting local museums, swimming, taking field trips, and shopping for the supplies they need to feed their animals and do their crafts. They also learn a variety of independent living skills such as cooking, baking and shopping. During the pandemic, Farm of Hope was forced to close by state order, but volunteers jumped in to ensure that the animals were cared for and they set up Zoom viewing schedules so that the "Growers" could check in on the farm and ensure their favorite animals were doing well. In 2020, Farm of Hope received a grant from the Lewis Family Foundation. Great supporters of their local community, the Farm of Hope grant was one of twenty-one grants made by the Lewis Family Foundation to support their local community.

United Way of Franklin County

The Kermit and Clarisse Hicks Foundation

In 2020, the United Way of Franklin County received a donation from the Kermit and Clarisse Hicks Foundation. An emergency fund was established to help Franklin County nonprofits and residents during the COVID-19 pandemic. To meet the increased need while complying with social distancing and health guidelines, organizations providing food had to adapt quickly and think of creative solutions for distribution, such as moving to online ordering, curbside pick-up, and home delivery. The United Way of Franklin County was able to assist the Central PA Food Bank feed an increased number of individuals who faced food insecurity.

Danville Area Community Center

The Hawkins Helping Hands Foundation

After closing during the pandemic, the Danville Area Community Center in Montour County was in danger of shutting down if it didn't raise more money. The Center has everything from afterschool programs, before-school programs, silver sneakers classes for senior citizens. The nonprofit was closed for nearly three months because of the COVID-19 pandemic. It reopened in June of 2020, but only about half of the members came back due to ongoing fears of community spread. The Danville Area Community Center relies on donors and membership fees to pay the bills. Hawkins Helping Hands, a new account within the PAA Foundation, donated over \$60,000 to keep the center operational.





Cops 'n' Kids

The Landis Family Foundation

Over one million books have been distributed to kids throughout the Lehigh Valley due to the Cops 'n' Kids literacy program, which received generous support in 2020 from the Landis Family Foundation. The organization encourages positive relationships between children and police while ensuring that every child has access — in their home to books and to the knowledge, inspiration and hope that such access provides. Due to the public health emergency of the Covid-19 pandemic, many of the events since March of 2020 have been held online, but volunteers continued to distribute books to children in need. The Landis Family Foundation also supported Big Brothers Big Sisters of the Lehigh Valley, Victory House of the Lehigh Valley, and Nam Knights, a brotherhood of American Veterans, Law Enforcement personnel, plus a few special and dedicated Patriot members who unite to assist veterans, members of law enforcement and their families.

Bethany Children's Home

The Wynn Family Foundation

At Bethany Children's Home youth have access to a variety of therapeutic, spiritual, and cultural services in addition to recreational activities. Youth reside on campus in one of our historic cottages with a family comprised of house parents, support staff and resident advisors. Recently, the home was certified as a "Specialized Setting," one of only four agencies in Pennsylvania, for victims of trafficking, no boundaries of age, race, ethnicity, culture, gender, gender identity, gender expression, sexual orientation, economic condition, physical or mental ability, or faith background. Bethany's Shelter Care program provides emergency services and immediate housing to youth ages 6-18. The Transitional Living Program helps young adults prepare to live independently in the community by offering them an opportunity to work toward independence. In 2020, Bethany Children's Home, located in Berks County, received a generous contribution from the Wynn Family Foundation. The Wynn Family Foundation also donated to Auto Dealers CARing for Kids Foundation, the Salvation Army of Philadelphia, and Daily Bread Community Food Pantry, among others.



Young Life

The Matt + Tiff Stuckey Foundation

At the beginning of the pandemic, Young Life area leaders asked if teens would like to meet online and explore the Bible. One area teen, Jason, was all in, and after the first day asked, “Can we do this every day?” Since then, the two have met through FaceTime five days a week in the afternoon to read Scripture and process God’s Word together. This is just one of the thousands of kids impacted by Young Life. In 2020, Young Life received generous donations from the Matt & Tiff Stuckey Foundation. Young Life is a group of caring adults who go where kids are, win the right to be heard and share the Gospel of Jesus Christ with them. Most of the funds given to Young Life each year come from individuals and organizations who are committed to making a difference in the lives of kids in their communities.



Operation Warm

The Auto Dealers CARing for Kids Foundation

In 2020, the Auto Dealers Caring for Kids Foundation continued its annual Driving Away the Cold new coat program, which purchased and distributed a record 53,928 new coats to Philadelphia area kids in need. One in six children in the Greater Philadelphia region lives in poverty and a warm winter coat is one of the essential items they often live without. The 171 dealer participants of this program are committed to changing that. They annually conduct a pledge program to help raise funds to purchase brand-new winter coats. The Auto Dealers Association of Greater Philadelphia also plays a part by donating a portion from every Philadelphia Auto Show ticket sold to its Auto Dealers Caring for Kids Foundation in support of the effort. The coats are then distributed by more than 150 social services agencies, YMCAs, school districts, and shelters in the area. This year’s contribution to the effort brings the program’s total number of coats given to 473,000 since 2008.



Hoyt Art Center

The Robert III and Joanne Preston Family Foundation

The Hoyt Art Center in Newcastle received a generous contribution in 2020 from the Robert III and Joanne Preston Family Foundation. A community center dedicated to the arts, the Hoyt continues to build its collections of fine art, decorative arts, antiques and china to educate current and future generations about the art and industry of our Southwestern Pennsylvania heritage. From the European paintings of our founding fathers to the contemporary work of Romare Bearden, Robert Motherwell and Wolf Kahn, each piece contributes to a chapter in the ongoing compilation of American culture. In addition, the center offers art classes to children and adults, events and concerts, and exhibitions on display. The Robert III and Joanne Preston Family Foundation also gave to support the Community Foundation of West PA and Eastern Ohio, Lawrence County Social Services, the United Way of Lawrence County, and the United Way of Youngstown and the Mahoning Valley, among others.



Wildlife Warriors

The Judy Faulkner and Art Riexinger Foundation

The Australian bushfires of 2019-2020 burned more than 46 million acres, 3,500 homes and thousands of other buildings were lost, and 34 people died. Several endangered species are also facing the risk of total extinction. For example, more than a third of the koala population is thought to have been killed, while the loss of habitat will also significantly impact the species' recovery. When Australian animal expert Steve Irwin died in 2006, he left behind a zoo, a legacy of helping wildlife, and a family that shared his passion. Irwin's widow, Terri, took over the Australia Zoo in Queensland. To cope with so many animals being admitted to the hospital due to the bushfires, in 2019, they opened a sea turtle rehabilitation center, a sea snake ward, a new bird recovery area, enclosures to house flying foxes and koalas injured or displaced by fires. In 2020, Wildlife Warriors received a donation from the Judy Faulkner and Art Riexinger Foundation. The Foundation also supported Sister Season Fund, Freedom Fighter, the Six Mile Run Volunteer Fire Company and Habitat for Humanity of Bedford County.



Paws for Purple Hearts

The Robert and Gail Hunter Foundation

Paws for Purple Hearts is the world's only service dog organization for wounded Service Members and Veterans that partners with Bergin College of Canine Studies. Through its unique mission to advance human-canine studies, it produces the some of the best service dog trainers and highest quality assistance dogs. Since 9/11, about 2.7 million American men and women have bravely served our country. Nearly half have returned with a service-related disability. A large portion of this group has some level of post-traumatic stress, traumatic brain injury, and other serious mental condition. In 2020, Paws for Purple Hearts received a donation from the Robert and Gail Hunter Foundation.

Ned Smith Center for Nature and Art

The Rolan E. and Patricia H. Ferris Foundation

The mission of the Ned Smith Center for Nature and Art is to merge the arts and the natural world and foster a celebration of both. Located in Millersburg, The Center celebrates the life and works of its namesake, the nationally recognized wildlife artist, naturalist and writer, Ned Smith. The Center's lands offer a tranquil outdoor experience on more than 500 contiguous acres of rustic beauty. Educational programs, concerts, events, an open-air amphitheater, and a children's discovery area are also available to visitors. In 2020, the Ned Smith Center for Nature and Art received a donation from the Rolan E. and Patricia H. Ferris Foundation.

Carnegie Museums of Pittsburgh


The Joseph and Nancy Mycka Foundation

In 2020, the Joseph and Nancy Mycka Foundation supported Carnegie Museums. A unique cultural organization with a legacy of discovery and outreach dating back to 1895, the Museums include four diverse, dynamic spaces: Carnegie Museum of Art, Carnegie Museum of Natural History, Carnegie Science Center, and The Andy Warhol Museum.

DeSales University

The Robert P. Kelly Family Foundation

In 2020, the Robert P. Kelly Family Foundation continued its history of giving to DeSales University with another generous grant. Pictured at right, Robert Kelly and Lorraine Kelly presented Father James Greenfield, OSFS '84, president of DeSales, with a check for \$15,000 in 2019. The Robert P. Kelly Family Foundation historically supports the DeSales Fund, which benefits student financial aid. The University, located in the Lehigh Valley, offers traditional, online, and hybrid courses and programs at the undergraduate and graduate levels. Named for St. Francis de Sales, the university was founded in 1964 as "Allentown College of Saint Francis de Sales". Mr. Kelly is a great supporter of a variety of causes and organizations in the Lehigh area, with a focus on education and programs the support children and teens.



York Catholic High School

The Giambalvo Family Foundation

York Catholic High School received a generous donation in 2020 from the Giambalvo Family Foundation. In 2018, York Catholic embarked on its first Capital Campaign to revive their facilities since 1959. In 2019, classrooms were updated and accommodated with air conditioning, a turf field was placed at the stadium, and an elevator was installed. Additional projects were planned for the summer of 2020 including renovated science labs, creation of a lobby-level student center, and relocation of the chapel. The 2nd Phase of the Capital Campaign includes renovation of the Junior High wing and additions to the stadium including grandstands, concession stand, locker rooms, and restrooms. Located in the City of York, York Catholic High School serves grades 7 through 12. To form habits in the area of service, the school monitors a program of Christian Service whereby each student is required to perform hours of non-remunerated service each year within a volunteer program or individually.

Williamson College of the Trades

The Stuckey Family Foundation

Williamson College of the Trades is located on a 220-acre campus in Delaware County. Each year approximately 100 students are offered admission. Through scholarship and grants, Williamson's tuition, room and boarding are at no cost to the student; making the college unique in the nation. The college currently offers Craftsman Diplomas in Carpentry and Masonry and Associate in Specialized Technology Degrees in Construction Technology (with an emphasis on carpentry or masonry); Horticulture, Landscaping and Turf Management; Machine Tool Technology; Paint and Coatings Technology; and Power Plant Technology. In 2020, Williamson College of the Trades received a generous grant from the Stuckey Family Foundation.





Horizons at Green Street Friends School

The Scott and Lucinda Friedman Foundation

Horizons is a national network of transformational education and enrichment programs that put low-income public school children on a path to success in school and life. At its core, horizons is a six-week summer program that takes place on school campuses across the country. In summer 2016, Horizons At Greene Street Friends School was launched in Germantown as the first Philadelphia program. Children start in kindergarten and return every year through middle school. National Horizons data show that students gain 2-3 months of reading and math skills each summer. When the schools was forced to close in March, learning shifted to a virtual format. Fears of students falling behind increased. Over the summer, Horizons assisted families with grocery gift cards and delivered academic materials to the homes of those students who could not connect virtually. Through online resources, students went on virtual field trips, participated in supplemental learning activities, and discussed their fears regarding COVID-19, which studies show have impacted Black and Brown communities more severely. Horizons and Green Street Friends School plans to return to in-person education for the summer of 2021. In 2020, Horizons at Green Street Friends School received a generous grant from the Scott and Lucinda Friedman Foundation.

PAA Scholarships

In 2020, \$180,000 was awarded to 14 students representing dealerships throughout Pennsylvania. Scholarships are in the amount of \$5,000 per year. Eight students were selected who are currently enrolled in, or are seeking enrollment in, an automotive technology program, and who are sponsored by a new car or truck dealer. These two-year awards can total \$10,000. Six students were chosen to receive scholarships in honor of their demonstrated charitable characteristics and their work to make a positive impact in their communities. The students are eligible for awards of up to \$20,000, if they continue to satisfy scholarship requirements. Due to COVID-19 shelter in place orders, PAA was unable to recognize the students at the dealerships. The annual golf outing in May of 2020 was also canceled.

In 2020, the PAA Scholarship Committee voted to discontinue the Community Service and Automotive Technology Awards and instead focus on providing tool grants to those entering the industry as automotive technicians.





Increase in Grants Distributed to Charities by Year




