To my colleagues and friends,





Minsi Trails Council - Boy Scouts of America *The Robert P. Kelly Family Foundation*

In 2019, Robert P. Kelly was awarded the Boy Scouts of America Whitney M. Young, Jr. Award for outstanding service in the development and implementation of scouting opportunities for low income youth. Mr. Kelly has been a great supporter of the Minsi Trails Council, located in the Lehigh Valley area. The local Minsi Trails Council, serves nearly 9,400 children and young adults and has three scout camps located in the Pocono Mountains. For over a century, the Boy Scouts of America has helped young scouts find adventure in their local community and in the great outdoors. With an emphasis on serving the community and helping children grow into prosperous adults, the Boy Scouts of America continues to be a guiding force in the lives of today's youth. In 2019, Mr. Kelly also gave generously to Boys & Girls Clubs, Gifford Youth Achievement Center, rescue missions, schools, and healthcare providers.

Sixers Youth Foundation

The David P. Kelleher and Marlo Pagano-Kelleher Foundation

The Sixers Youth Foundation envisions communities where all children can create, pursue, and realize their dreams and live productive lives. Established in 2015, the Sixers Youth Foundation is the nonprofit extension of the Philadelphia 76ers. The foundation is focused on youth development across the greater Delaware Valley and believes in utilizing the power of basketball to inspire future generations. They focus on making an impact in the communities where 76ers fans live, work and play. The Sixers Youth Foundation also partners with nonprofit organizations to help build on their strengths, serving young people between the ages of seven and fourteen. In 2019, the Sixers Youth Foundation was supported by the David P. Kelleher and Marlo Pagano-Kelleher Foundation.





Operation Warm
The Auto Dealers CARing for Kids Foundation

One in six children in the Greater Philadelphia region lives in poverty and a warm winter coat is one of the essential items they often live without. To fill this need, in the fall of 2019, the Auto Dealers Caring for Kids Foundation distributed a record 52,700 brand-new winter coats through its annual Driving Away the Cold program. This year's contribution brings the program's total number of coats given to 419,700 since 2008. The program is supported by local new car dealerships, auto industry stakeholders and proceeds of the Philadelphia Auto Show. The funds raised are used to purchase brand-new winter coats that are then distributed through 220 social services agencies, school districts, churches, and shelters in the area, including 29 regional YMCA branches. The Auto Dealers Caring for Kids Foundation also generously supported the YMCAs in the five-county area in 2019.

Children's Home of Easton
The Greater Lehigh Valley Automobile Dealers Association Foundation

In 1885, the Children's Home of Easton was founded to care for orphaned and abandoned children. By 1960, the Children's Home of Easton's focus shifted from an orphanage to a residential treatment home for adolescents from dysfunctional families who displayed emotional problems. Today, the Children's Home of Easton can house approximately 80 children on its campus and 70 off campus in group and foster homes. The Children's Home of Easton provides a caring, nurturing environment for children in need as well as assistance to their families. The Home also provides a continuum of services, including group care and other family-like programs in a safe, compassionate atmosphere. The Home guides, supports and encourages children to believe in their own self-worth and reach their full potential. In 2019, the Greater Lehigh Valley Automobile Dealers Association Foundation gave to the Children's Home of Easton and various organizations that supported the health and well-being of children in the Greater Lehigh Valley.





Pittsburgh Vintage Grand Prix *The Greater Pittsburgh Automobile Dealers Foundation*

The Greater Pittsburgh Automobile Dealers Foundation has been the Presenting Sponsor of the Pittsburgh Vintage Grand Prix (PVGP) and its charities since 2012, benefiting autistic and intellectually or developmentally disabled individuals in the Pittsburgh region. The PVGP is recognized nationally and internationally for its ten days of events culminating with a vintage auto race on the streets of Pittsburgh around Schenley Park, where the golf course is turned into an international car show. The Pittsburgh Vintage Grand Prix, presented by the Greater Pittsburgh Automobile Dealers Foundation, is the nation's largest vintage street race with 10 days of racing, car shows, parties, parades and motorsport events.



Allison-Antrim Museum *The Paul K. and Anna E. Shockey Family Foundation*

It was June 15, 1863, when Confederate Rebel troops started to march across the Mason-Dixon Line and touched the homeland soil of citizens in Antrim Township and Greencastle. By the end of June, the citizens had watched from their farms, homes and the sidewalks for days on end as the Confederates made their way to Gettysburg. Seventeen year old Dolly Harris rushed to the street in front of the leader of the southern band, waved the stars and stripes, and roundly denounced the troops as "traitors to their country, cut throats, and plunderers." General Pickett removed his hat and saluted the courageous young lady and the flag. Following suit, Pickett's men also saluted young Dolly, and the division's band passed by. It was more than 20 years later, at the Gettysburg Reunion in 1887, that the flag-waving girl incident was first mentioned in a speech made by Colonel William Aylett, of Pickett's division. Aylett said, "Why the bravest woman I ever saw was a Pennsylvania girl who defied Pickett's whole division as we marched through the little town called Greencastle. Saturday, November 2, 2019, marked the 174th birthday of Frances "Dolly" Harris Leshar. Bonnie Shockey hosted a presentation about Dolly Harris in the Allison-Antrim Museum Barn. Great supporters of Pennsylvania history, the Paul K. and Anna E. Shockey Family Foundation generously gave to Allison-Antrim Museum and to PA Museums in 2019, as well as numerous other worthy charities.



Capitol Theatre Center Foundation

The Allan and Barbara Jennings Family Foundation

Originally known as “The Theatorium” and later “The Jackson,” the Capitol Theatre in Chambersburg was built as a one level dance hall, with the balcony added in 1917 for films. The Appell family, who built the Strand Theatre, bought The Jackson in 1926, remodeled it again, and reopened it as the Capitol Theatre in 1927. The theatre continued as a popular movie house until 1977. The theatre has undergone smaller, cosmetic upgrades over the last few decades including the restoration of the theatre’s “Mighty Wurlitzer” organ in the 1980s; and, the latest improvement for the theatre involved a \$2 million facelift. Inside the 450-seat theatre, a digital cinema projector replaces a traditional film projector, and an automated screen replaces the hand-pulley screen and curtain system previously used. In 2019, the Capitol Theatre received a donation from the Allan and Barbara Jennings Family Foundation.

Pennsylvania Equine Rescue and Retirement Foundation

The Landis Family Foundation

The Pennsylvania Equine Rescue and Retirement Foundation, which received a generous grant in 2019 from the Landis Family Foundation, is committed to providing educational, personal development and community outreach through an equine intervention program for active and retired military personnel, troubled teens, and dementia patients and their care partners. Horses are considered a valuable partner in physical and emotional healing to develop confidence. Under supervision, participants are able to safely groom, feed and walk the horses. Another valuable aspect to the community outreach program is offering emergency response teams and firefighters education on helping save horses and other large animals in catastrophic situations. Large animal rescue is not widely understood in emergency services. Pennsylvania Equine Rescue is also a proud member of the Unwanted Horse Coalition and Equine Rescue Network, rescuing slaughter-bound, neglected, abandoned, lost, stolen, or missing horses in the United States. Currently, there are over 160,000 unwanted horses in the United States and over 140,000 horses are shipped to Canada and Mexico each year to be slaughtered.





East Hempfield K9 Unit

The Allen Family Foundation

In 2019, East Hempfield K9 Unit received a donation from the Allen Family Foundation. The K9 Officer supports the patrol and investigative functions of the agency and enhances officer and citizen safety. Because of their superior senses of smell and hearing, and physical capabilities, the trained law enforcement canine is a valuable supplement to police manpower. K9 Ringo, pictured at left, was a male sable German shepherd who was born in the Czech Republic. He is certified in patrol, tracking, and narcotics detection. With his human partner, Ringo adds an exciting dimension to law enforcement in East Hempfield Township. Recently, K9 Tundra was purchased and began training.

York County Libraries

The Giambalvo Family Foundation

Three York County Libraries have renovation and expansion plans in their near future. The endeavor marks the first simultaneous, multi-location expansion project in the York County Libraries' 45-year history. Libraries are the key to powering progress and elevating the quality of life of those in the community, young and old, by fueling the types of knowledge that are essential to success. In 2019, York County Libraries received a generous grant from the Giambalvo Family Foundation.

Hope Enterprises

The Blaise Alexander Family Foundation

A 2013 graduate of Selinsgrove High School, Chasity's participation in Hope's Community Employment Services has helped her to gain the life skills to be able to find and work a job she enjoys. With Hope's support, she's also learned how to drive, how to cook, how to manage money and how to care for her pets. Through Hope Enterprises, Chasity became independent. Hope Enterprises was founded in 1952 by physician Dr. Max E. Miller, and his wife, Leona, as well as other parents and community leaders in Williamsport. From the beginning, the organization was a front runner in providing community services to people with intellectual disABILITIES. In 2019, Hope Enterprises received a grant from the Blaise Alexander Family Foundation.





Operation Our Town *The Matt & Tiff Stuckey Foundation*

It was a dramatic increase in violent crime and drug use that brought about the formation of Operation Our Town in 2006 in Altoona. A group of concerned citizens, determined to find a way to fight back, formed an exploratory group. What they discovered was that most area organizations, including law enforcement, did not have the resources needed to deter and reduce the criminal stronghold in the neighborhoods. Within a few short months, dozens of local businesses committed financial and other support to “take back the neighborhoods.” Partnerships were forged between Operation Our Town and existing organizations with proven law enforcement, treatment and prevention programs. Today, significant progress has been made to reduce drug activity and associated crime. In 2019, the Matt & Tiff Stuckey Foundation generously donated to Operation Our Town to continue the good work the community group is achieving in the fight against crime.

Women’s Resource Center *The Pompey Auto Group Foundation*

In 1976, a small group of determined and courageous women founded the Women’s Resource Center to address the social injustices women and children faced, especially violence and oppression experienced at the hands of male partners and male community members. With an abundance of determination, they worked to raise funds to aid victims through advocacy, education, and social change. In 1982, staff and volunteers raised enough money to open a safe house where victims and their children receive emergency shelter. Through federal and state grants and foundation funding, the Center remains stable and continues to provide services to those in need. Today, the Women’s Resource Center remains a dynamic force in the community, helping 52,087 women and children in Lackawanna and Susquehanna Counties rebuild their lives free of violence and fear. Of that number, 42,138 were adult and child victims of domestic violence and 9,949 were victims of sexual abuse. Those reaching out for help come from all walks of life, socioeconomic backgrounds, education, ethnicities, and sexual orientation. Services are free. In 2019, the Women’s Resource Center received a generous grant from the Pompey Auto Group Foundation.

Little Sisters of the Poor *The Sullivan Numrich Foundation*

At the request of the St. Vincent de Paul Society in April 1872, the Little Sisters of the Poor were invited to establish a home to care for the elderly in Pittsburgh. As the number of elderly in their care grew, an additional home was erected in 1885 along Penn Avenue in the Garfield neighborhood. The Little Sisters were recognized throughout the City as they went about in their horse and buggy begging for food and essential needs for the home. They were beloved by all for their selfless work in caring for the elderly poor. Continuing the work, today the Little Sisters of the Poor offer the neediest elderly of every race and religion a home where they will be welcomed. The current facility, located on nine hilltop acres, opened in 1923. Extensive renovations and additions have been made since then, including the construction of 45 independent living apartments with communal areas that make the location feel more like a college dormitory. Ninety-three residents and 14 sisters occupy the site. In 2019, Little Sisters of the Poor received a grant from the Sullivan Numrich Foundation.





Community Check Up Center Harrisburg

The Ballantine Family Foundation

The Community Check-Up Center of South Harrisburg, improving the health and wellness of low-income women and children through high-quality compassionate care, is staffed by a Board Certified Gynecologist, Pediatricians, Nurse Practitioners and Medical Assistants who are passionate about health care. Celebrating 25 years of getting locals the help they need, regardless of their ability to pay, the Community Check-Up Center in Hall Manor was started in 1994 by local mothers who were seeking care for their children. “Truthfully, nobody, not even us, thought we would last this long,” says Dr. Meada McAllister who’s been with the check-up center for more than two decades. “We don’t turn anyone away from healthcare here,” says Karen Stilp, a nurse practitioner at the Community Check-Up Center. “That’s a big challenge for us. We have to be very creative when it comes to funding.” In 2019, the Community Check Up Center Harrisburg received a grant from the Ballantine Family Foundation.

Fox Chase Cancer Center

The Joseph and Mary Faulkner Family Foundation

In 2019, the Fox Chase Cancer Center received a generous grant from the Joseph and Mary Faulkner Family Foundation. Fox Chase Cancer Center is a National Cancer Institute-designated Comprehensive Cancer Center, research facility, and hospital located in the Fox Chase section of Philadelphia. The center is part of the Temple University Health System and specializes in the treatment and prevention of cancer. The center was formed in 1974 by the merger of the American Oncologic Hospital, which was founded in 1904 as the first cancer hospital in the United States and the Institute for Cancer Research, founded in 1927. Today it has almost 2,400 employees and an operating budget of \$300 million. Research is conducted in more than 80 laboratories by a staff of more than 325 physicians and scientists who hold medical degrees, Ph.D.s or both. Fox Chase’s 100-bed hospital is one of the few facilities in the country devoted entirely to cancer care.





Gift of Life

The Scott Auto Group Foundation

At just 13-years-old Marquis Wood suffered a fatal asthma attack that left his family devastated. Amidst the darkest time in her life, Marquis' mother, Markita, made the decision to donate Marquis' organs to save others. "I said yes to donation that day and that decision continues to give me much comfort. I know my son is a hero who saved the lives of three other kids. They walk the earth every day because of Marquis," Markita said. Three young men received Marquis' kidneys, liver and heart. Gift of Life Donor Program is the nation's leading organ procurement organization, coordinating more organ and tissue donors than anywhere else in the United States. Headquartered in Philadelphia, Gift of Life serves as a critical link between individuals and families who make the generous decision to donate organs and tissues, and those who need a transplant. They provide compassionate care for donors, transplant recipients, and their families, and are

committed to educating the public about the need for donor registration. Gift of Life is part of the nationwide organ and tissue sharing network run by the United Network for Organ Sharing. In 2019, Gift of Life received a generous grant from the Scott Auto Group Foundation.

Children's Hospital of Pittsburgh

The Deborah Numrich Campbell Foundation

The local cardiology team that took on Miranda Jones' congenital heart condition after she was admitted to a Tennessee hospital in Memphis had run out of options, leaving the teenager at the most literal of dead ends. Her heart had arrested twice while in surgery, and her time on life support equipment was expected to be short when doctors reached out to the Heart Institute at Children's Hospital of Pittsburgh of UPMC. Children's Hospital dispatched its specialized transport team to bring Miranda to Pittsburgh, but upon arrival, her situation was found to be even more dire, when doctors discovered that she had suffered a massive stroke. The notion of any kind of heart surgery seemed out of the question. Yet nine months later, Miranda began her senior year of high school, much the same as any 17-year-old, thanks to her own strong spirit, pioneering capabilities developed by Children's Heart Failure and Recovery team, and a nearly full recovery from the stroke, which together made her a candidate for a successful heart transplant. Nationally, UPMC Children's Hospital is ranked for excellence. "It is an extraordinary achievement to be recognized as one of the best children's hospitals in the country," said Mark Sevco, president, UPMC Children's. "The rankings reflect our staff's dedication to creating the ultimate patient care experience by providing compassionate and world-renowned care for every single patient and family every single day." A long-time supporter of Children's Hospital of Pittsburgh, the Deborah Numrich Campbell Foundation provided a grant in 2019, supporting children's healthcare and medical research.





Abington Friends School

The Faulkner Family Foundation

When the troops of Generals Washington and Howe marched down Washington Lane in 1777, the third generation of students at Abington Friends School watched their passing. A powerful academic program is at the heart of Abington Friends School, igniting imagination and a love of learning as they prepare student for college and lives beyond. The school believes in education that speaks to every dimension of who children are as human beings, developing the intellect, teaching students to express themselves clearly and with conviction, giving them practice in leadership roles and helping them to understand the need to contribute to the community. With this breadth of experience and freedom to flourish, they leave AFS as lifelong learners who are confident, caring and well-prepared to lead lives of purpose. Graduating classes range in size from sixty to seventy students. In 2019, Abington Friends School received a generous donation from long-time supporter the Faulkner Family Foundation.

Horizons

The Scott and Lucinda Friedman Foundation

Horizons is a national network of transformational education and enrichment programs that put low-income public school children on a path to success in school and life. At its core, horizons is a six-week summer program that takes place on school campuses across the country. In 2016, horizons at Greene Street Friends School was launched in Germantown as the first Philadelphia program. Children start in kindergarten and return every year through middle school. National Horizons data show that students gain 2-3 months of reading and math skills each summer (their peers typically lose 2-3 months), plus they learn to swim and explore music, theater, art and other activities that build self-confidence and cultivate creativity and leadership. 98% of horizons students graduate from high school and 96% enroll in post-secondary education. In 2019, Horizons received a grant from the Scott and Lucinda Friedman Foundation.

Gould Academy

The Eric and Deborah Hessinger Foundation

Gould Academy is a private, co-ed, college preparatory boarding and day school founded in 1836 and located in the small town of Bethel, Maine. The location in the White Mountains of western Maine gives them a unique outdoor classroom right at the school's doorstep. Students explore robotics with the school's Navy-class submarine in the local pond, explore the school's trails on mountain bikes and build their own skis in the IDEAS Center. Students also have opportunity to travel to China, Ecuador, Peru, or Tanzania with the Ninth Grade Four Point immersion experience. The school's goal is to prepare academically motivated students for college and help them to become independent-minded, ethical citizens who will lead lives of purpose, action, excellence, and compassion in a dynamic world. In 2019, Gould Academy received a grant from the Eric and Deborah Hessinger Foundation.



Lackawanna College

The Earle M. Mitchell Memorial Foundation

Lackawanna College offers bachelor's degree, associate degree and certificate programs at six locations in northeast Pennsylvania. The private four-year college has evolved with an open admissions policy and enrolls approximately 1,770 students. While the college offers a variety of traditional academic programs, many of its popular majors are centered on vocations, such as law enforcement, early childhood education, culinary arts, and accounting. Lackawanna College also operates Police Academies at its Scranton campus and Hazleton Center. Industry-specific degrees were created at the School of Petroleum and Natural Gas to fill the demand of the Marcellus Shale career opportunities in the work force. In 2019, Lackawanna College received a grant from the Earle M. Mitchell Memorial Foundation.

Lancaster County Career & Technology Center *The Allen Wenger Foundation*

In 2019, Lancaster County Career & Technology Center received a grant from the Allen Wenger Foundation. The Lancaster County Career & Technology Center is a full service career and technical school dedicated to preparing high school students and adults for careers in various industries, including the automotive industry.



Transportation Technology students earn National Occupational Competency Testing Institute Certificates and PA Skills Certificates. The program is designed so that students work side by side with experienced automotive technicians. With the average age of today's technician between fifty-five and fifty-eight, it is estimated that half of technicians nationwide will retire in the next decade. The need for qualified technicians has never been greater.

Waynesburg University

The Fox Family Foundation

Waynesburg University educates students to make connections between faith, learning and serving so they might faithfully transform their communities and the world. As a Christian comprehensive University, we strive to inspire and challenge every undergraduate and graduate student to a life of leadership and purpose for the glory of God. As attention on higher education is turning toward outcomes and fiscal responsibility, new rankings systems that focus primarily on value and job placement are being developed. Consistently ranked as a top school within these systems, Waynesburg University has emerged as a national leader in educational value. In 2019, Waynesburg University received a grant from the Fox Family Foundation.

PAA Scholarships

In 2019, \$205,000 was awarded to 17 students representing dealerships throughout Pennsylvania. Scholarships are in the amount of \$5,000 per year. Eleven students were selected who are currently enrolled in, or are seeking enrollment in, an automotive technology program, and who are sponsored by a new car or truck dealer. These two-year awards can total \$10,000. Six students were chosen to receive scholarships in honor of their demonstrated charitable characteristics and their work to make a positive impact in their communities. The students are eligible for awards of up to \$20,000, if they continue to satisfy scholarship requirements. Since 2006, over \$2.7 million in scholarships have gone to students affiliated with automotive and truck dealerships in Pennsylvania, touching over 150 different dealerships across the state.



Increase in Grants Distributed to Charities by Year




Fund Balance History
